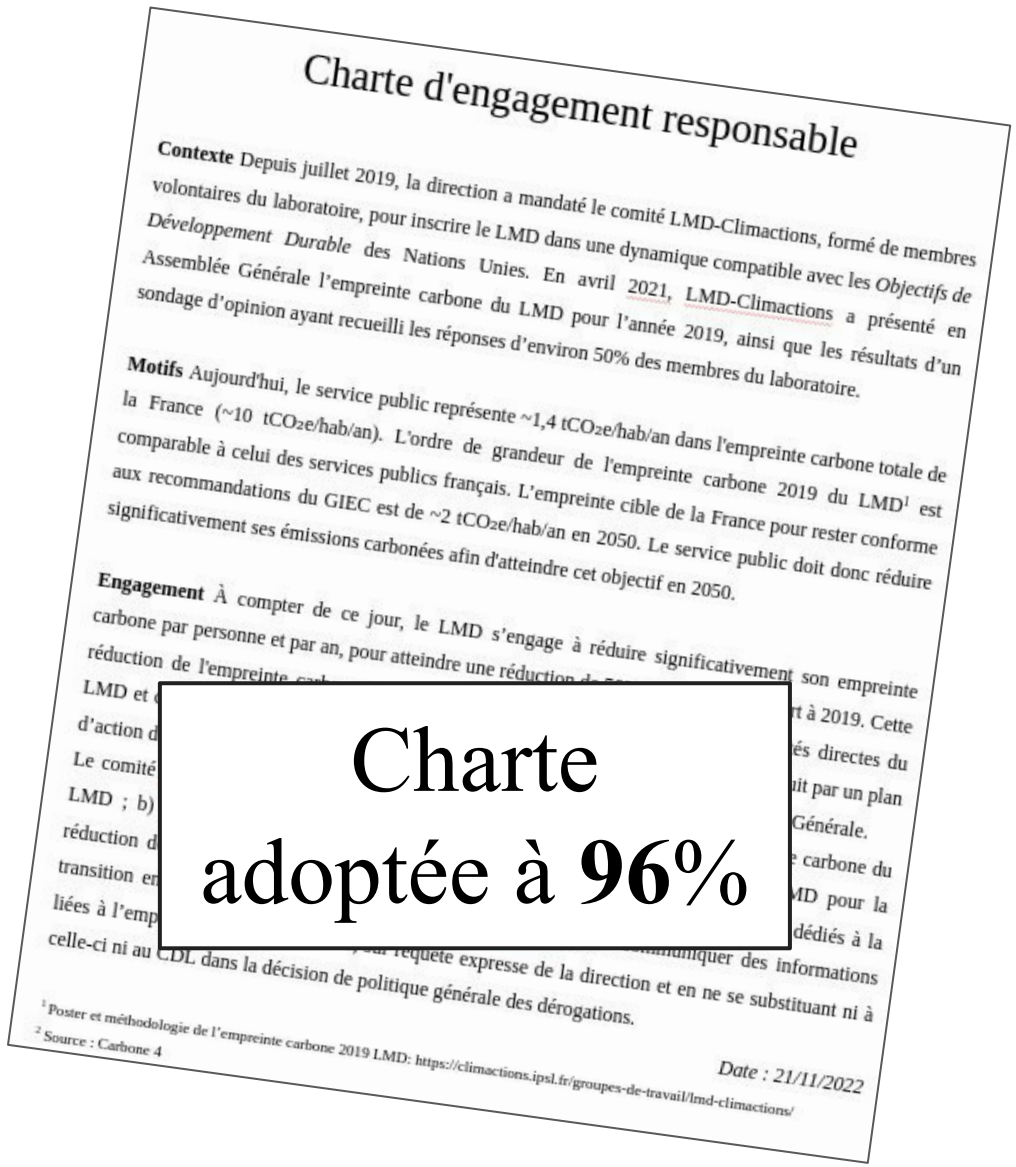

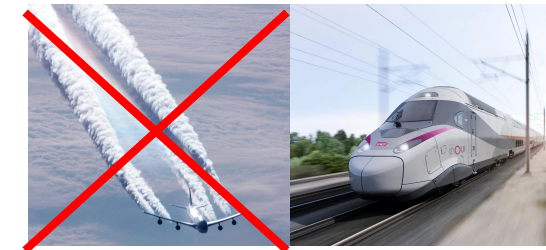

Social and Environmental Charter

Background Since July 2019, the LMD director has commissioned LMD-Climactions, a group formed with volunteers from the lab, to put LMD on a path that is compatible with the Sustainable Development Goals of the United Nations. In April 2021, LMD-Climactions presented the 2019 LMD's carbon footprint to the General Assembly, along with the results of an opinion survey that received responses from approximately 50% of LMD's members.

Rationale Today, the public service accounts for ~1.4 tCO2e/inhab/year in the total carbon footprint of France (~10 tCO2e/inhab/year). The order of magnitude of the 2019 carbon footprint for LMD³ is compliant with the footprint of French public services. The target for France's total footprint in 2050 to fulfill IPCC recommendations is ~2 tCO2e/inhab/year. The public service thus needs to significantly reduce its carbon emissions in order to reach this 2050 goal.

Commitment As of today, LMD commits to significantly reduce its carbon footprint over the next year to reach a reduction of 50% by 2030, compared to 2019. This commitment is part of the LMD's environmental policy and will be communicated to all stakeholders. The LMD-Climactions group will be responsible for monitoring and reporting on this commitment. The LMD-Climactions group will also be responsible for communicating information related to the environmental footprint, at the request of management and without replacing them or the Laboratory Council in deciding on the general policy for derogations.
